"The Day America Died"

THE DOWNWARD SPIRAL BECAME IRREVERSIBLE in the Wall Street crash of October, 1929, when millions of shares were unloaded. Panic reigned on the floor of the New York Stock Exchange & mounted police were stationed outside to maintain order.

AS THE IMPACT OF THE CRASH BECAME CLEAR, investors committed suicide & banks shut their doors; the United States sank into the Depression, its worst crisis since the Civil War, & the world went down with it. Fifty years later, two Britain-based writers have reconstructed the event, using it to focus on America in the 20s in all its greed & final horror.

THEIR BOOK, "THE DAY AMERICA DIED", is scheduled for publication in October by Doubleday to coincide with the 50th anniversary of the crash. NBC & 20th Century

Fox have bought the television & film rights. Its authors, Gordon Thomas & Max Morgan-Witts, are not economists. The book offers insights into how people react under stress—particularly stress on their pocketbooks.

IN ORDER TO RECONSTRUCT THE PERIOD, the authors interviewed about 200 persons. The book follows 25 characters thru' the ebullient late 20s to the crash itself & the incredible social decline that ensued. Many Americans were not prepared. One stockbroker's wife called the crash "just a tinkle of tea cups, really"—before she & her husband lost all.

EVANGELINE ADAMS, FORTUNE TELLER TO KING GEORGE V & J.P. Morgan, had predicted a week in advance that the stock market would crash. But when it did, she was incredulous. She lost a hundred

thousand dollars.

"A LOT OF PEOPLE I INTERVIEWED ARE STILL BITTER," said Morgan-Witts. Many who lost their assets swore never again to buy on credit. Many marriages, Morgan-Witts said, were ruined as husbands or wives discovered their mates had secretly frittered away savings on

the stock market.

COULD IT HAPPEN AGAIN? "YES," says Thomas, "people are greedy, people will overstep the mark." Adds Morgan-Witts, "Things were tightened up considerably after the crash, but we can still be manipulated."

War Threatens South America!

OLD BORDER QUARRELS THREATEN TO BRING OPEN WAR TO SOUTH AMERICA. Pope John Paul II dispatched a special envoy to mediate the dispute between Argentina & Chile over islands & territorial waters off the tip of South America. Also,

BOLIVIA IS NOW VOWING TO RECOVER A LOST COASTLINE that has left it landlocked since its defeat in the War of the Pacific with Chile 100 years ago.

SOUTH AMERICA'S MILITARY MEN are also wondering how to run the governments of the countries they now lead or how to turn these governments over to civilians. Brazil & Venezuela inaugurate new presidents this coming March. Brazil's

armed forces, in power for 15 years, chose Gen. Joao Baptista Figueiredo to continue a cautious move toward political freedoms under indefinite military rule, a system admired by generals running Argentina, Chile & Uruguay.

THE NEW PRESIDENT OF VENEZUELA, LUIS HERRERA (Shaul: He is avowedly anti-sects & backed by some of our enemies!) has promised austere management of its oil wealth to head off economic woes. Generals running Bolivia, Ecuador & Peru promised to restore democracy in 1979 presidential elections, but events indicate that is easier pledged than done.—Especially with wars threatening!

A Russian Imprint on California!

DAD: I think this is fascinating!—I could've been born in Russia if the Czar hadn't been so stubborn!—Ha!

FORT ROSS, CALIF.: There are Russians living in the Soviet Union who can trace their roots to California Indians. And there are Pomo Indians living in Northern California

who can trace their heritage to Russian blood-lines & to this day have a number of Russian words in their language. Why?—

THERE WAS A RUSSIAN OUT-

POST THAT EXISTED IN CALIFORNIA from 1812 to 1841, covering 125 miles of Northern California coastline, 65 miles north of San Francisco.—Russia's only base in the continental United States.

"MOST OF THE RUSSIANS WHO WERE ASSIGNED TO FORT ROSS came here without wives," noted Russian-history professor Nicholas Rokitskiy of Foothill College in California. "Many intermarried with local Indians. Other Russians stationed at Fort Ross returned to their homeland with their Indian wives & Russian-Indian children."

IN 1812, THE RUSSIANS LAID CLAIM to 125 miles of California coast from Point Reyes, just north of San Francisco, up to Point Arena in Mendocino County, as a base to raise food for the Russian settlements in Alaska & on the Siberian coast, & to extend the Russian fur trade.

BY 1841, THE RUSSIANS HAD DECIMATED THE CALIF. SEA-

OTTER POPULATION, & farming along this part of the California coast proved to be marginal at best. The Governor of Russian Alaska went to Mexico City in 1839 to negotiate with Mexico for more productive land in the Sacramento Valley. Mexico agreed, if Russia agreed to recognize the independence of Mexico from Spain.

"BUT CZAR NICHOLAS I, a foe of revolutionary change, would not deal with a revolutionary Mexican government & ordered the Russian colony in California to disband," Rokitskiy said.

"IF THE RUSSIANS HAD HELD ON another seven years, with the coming of the Gold Rush, the course of world history would have been dramatically different," said John McKenzie, state park historian at Fort Ross. "If the Russians hadn't pulled out & had maintained control of the coast north of San Francisco, this could be part of the Soviet Union today."

Billy Carter Speaks Out!

PRESIDENT CARTER SAID HE hopes the people of the United States realize he has "no control" over his brother, Billy, whose involvement with a group of visiting Libyan officials and businessmen has become an embarrassment.

BILLY CARTER WAS HOST TO A 60-MEMBER LIBYAN DELEGATION and then explained himself with some apparent anti-Semitic remarks. The President's brother was

quoted as saying, "THERE'S A HELL OF A LOT MORE ARABIANS than there is Jews" and then blamed what he termed the "Jewish media" for giving negative views on Arab countries.

AYATOLLAH'S DOCTRINE:

Total Power For Religion!

DAD: The fanaticism of Iran's coming gov't.—No love or mercy!

(Ayatollah Ruhollah Khomeini's vision of the new political order for Iran spelled out in his book "Islamic Government". Here are some passages.)

RULE HAS BEEN ENTRUSTED TO THE RELIGIOUS EXPERTS. Verily, God will punish and call to account anyone who takes issue with their authority. Government in Islam is constitutional in the sense that those in power are bound by a group of conditions and principles made clear in the Koran. Thus Islamic government is a government of divine law.

AUTHORITY TO LEGISLATE belongs exclusively to God. No others, no matter who they may be, have the right to legislate, nor has any person the right to govern on any basis other than the authority that has been conferred by God.

SINCE ISLAMIC GOVERNMENT IS A GOVERNMENT OF LAW, it is the religious expert (faqih) and no one else who should occupy himself with the affairs of government. He should implement the canonical punishments, just as the Prophet did, and he should rule according to God's revelation...

...80 LASHES AS A PUNISHMENT FOR THE WINE DRINKER, or 100 lashes for the fornicator of ill repute, the stoning to death of a male or female fornicator of previously chaste reputation. The rules for criminal punishment in Islam came into being to prevent obscenity and undesirable immoral behavior among a great and far-flung people.

THERE IS NO ROOM FOR OPINIONS OR FEELINGS in the system of Islamic government. Rather, the Prophet and the Imams and the people all follow the wish of God and his laws. We want a ruler who would cut off the hand of his own son if he steals, and would flog and stone his near relative if he fornicates.

BEFORE US WE SEE THE JEWS MAKING A MOCKERY OF THE KORAN. It is our duty to shout at the top of our voices until people understand that the Jews and their foreign masters are plotting against Islam and are preparing the way for the Jews to rule over the entire planet. I greatly fear that, by their own special methods, they will indeed realize their desired aims...we may wake up one morning and find a
