

Make It - Or Make Do!

Sewing Tips to Help You Use What You've Got!

From Diana; U.S.A.:

THE CHILDREN & I GET LOTS OF CLOTHES DONATED TO US. Most of our friends know how little money we have & they know that I sew well, so that I can alter something if needed, or take it apart & make something else. I'd like to share some suggestions on what to do with donated clothing:

WHEN YOU GET SOMETHING & IT DOESN'T FIT, or you don't like it, consider these: Can you, or a friend or someone in your home change it: Add a collar, take off the sleeves, change the buttons, shorten it, make a full skirt into an A-line, dye it etc.?

OR CAN YOU MAKE IT INTO SOMETHING ELSE?—Especially good for children's clothing! A tacky, out-of-style man's wool suit can make a beautiful jumper for a girl, or outfit for a boy. (Boy's clothes are for more experienced seamstresses.)


I ONCE TOOK A LARGE MAN'S SWEATER with moth holes in it & made a great sweater outfit for my 3-month-old baby boy. The key to altering or cutting up sweaters is to stitch the area to be cut before you cut—to keep it from unraveling. For example, in the one here you stitch loosely around the shape of each piece you want to cut out. This also applies if you want to cut a sweater down to make it smaller—or maybe to cut it to make a vest out of it.—& don't cut it until you're ready to sew it, so it doesn't have a chance to get unravelled.

IF THERE'S REALLY NO HOPE FOR THE GARMENT ITSELF, strip it for what it's worth!—Take off the buttons, cut out the zipper, any belt, buckles or other hardware.—

These things are expensive to buy! String the buttons together so they don't get scattered, same with snaps etc.

COULD A DOLL IN YOUR HOUSE USE A DRESS?—Or outfit? It only takes a little time & is small enough a project that you don't need a machine, & little girls appreciate it so much!

IF YOU LIKE THE STYLE, but not the colour, or it's worn out, cut it apart carefully to make a pattern, being sure to add on for the seam allowance if you've had to cut it off. I did this recently with a favourite white blouse that got stained & ruined. Lay the pieces out on any paper to make the pattern by drawing around the pieces you've cut apart. Brown shopping bags, or brown wrapping paper are great, but you can even use newspaper, if you have to—but don't use newspaper for cutting out something light or white!



WHEN I FIRST FOUND THE LORD IN CANADA, some of my 1st contact with real Christians were the Mennonite farm families living outside Vancouver, B.C. Most of them were

comfortably well off. But what impressed me was how frugal they were, even now, not wasting anything & doing lots of canning & making things for their home themselves.

I'M NOT SUGGESTING THIS TO TAKE TIME AWAY FROM WITNESSING OR READING THE WORD, but for example while watching the evening news or just sitting around fellowshipping or something like that, your hands could be busy crocheting a warm scarf for someone, or mittens, slippers, sweater, hat, whatever. It's easy to learn & knowing how to do things like this can save money, & supply some of your needs.

IT'S GOING TO GET TOUGH-ER—NOT EASIER—TO SURVIVE & I feel we need to learn to make things & make-do so we're more prepared for hard times ahead! Also creating practical things can give some people who need it a creative outlet! Make it, or make-do! Love, Diana.

HELPFUL HOME HINTS!

IF YOUR IRON STICKS OR BECOMES SOILED when ironing, don't wait for it to cool.—Just sprinkle some salt on a cloth & iron over it a few times & the iron is clean again.

Grand Jury Indicts Scientologist's Father, Deprogrammer on Kidnaping Charges

Controversial religious "deprogrammer" Ted Patrick and seven other persons were indicted by the San Diego County Grand Jury on kidnaping charges stemming from the alleged abduction of a Los Angeles woman who says she was held against her will for 37 days in September and October.

The indictment, disclosed Friday, was the second one this year against Patrick, who for a number of years has boasted of being in the business of "deprogramming" and charges thousands of dollars to parents who want to get their children—often adults themselves—to forsake various religious cults or sects.

The victim of the abduction outlined in the indictment is Paula Janet Dain, a 24-year-old former model and cosmetology student who, contrary to the desires of her father, became active in the Church of Scientology.

Indicted on conspiracy, kidnaping and false imprisonment charges along with Patrick were Dain's father, Dr. Jack Dain, her stepmother, Mary Dain, and five Patrick associates: Sandra Sack, James Rowe, Betty Beady and two women identified only as Karen and Sarah.

All but Karen and Sarah surrendered to San Diego authorities Friday and were released either on their own recognizance or after posting bail.

The case is an unusual one not only because of the period of time Dain was allegedly held against her will before escaping, but because authorities

ties have as a key witness a former Scientologist who was present during four days of the attempted conversion of Dain. The woman, a vocal Scientologist critic from Toronto, has said she was booted out by Patrick because she did not condone the young woman being held against her will.

The indictment gives only the barest information about the alleged abduction of Dain Sept. 1 from the Fullerton home of her father, who is a surgeon.

when she was being held against her will and the couple also pleaded with Paula to forsake her beliefs in Scientology.

Suspected of having a role in the disappearance of Paula Dain, her father was the subject of a habeas corpus hearing in Orange County Superior Court three months ago. He declined to answer any questions about his daughter's whereabouts on grounds the responses might tend to incriminate him.

McLean said Dain was fed well during her captivity and was not physically abused or deprived of sleep, but was

However, interviews by The Times with Nan McLean, a Scientologist-turned-critic who was with Dain, and with Dain's mother, provided additional details.

Patrick has refused to return phone calls from The Times and Jack Dain's secretary said several weeks ago he was refusing to answer questions from reporters.

Paula Dain's mother, Diane Lapworth, who divorced Jack Dain seven years ago and remarried, said her daughter was coaxed by her stepmother to her father's home Sept. 1 to have her car fixed and then to go to a party of a mutual family friend.

When the Dains arrived at a home in Laguna Beach, Paula later would tell her mother, she walked into a bedroom where she was confronted by Patrick.

"Patrick started talking to her and Paula said 'I don't have to listen to this,'" Mrs. Lapworth said. But when her daughter started to turn away, she allegedly was grabbed by several women who threw her on a bed and said she was "going to stay for a while."

Paula reportedly told her mother that in the following weeks she was moved about to various locations in San Diego County, was subjected to verbal harassment and harangues by Patrick and others about the "evils" of Scientology—which describes itself as an applied religious philosophy.

Her father and stepmother, according to McLean, an outspoken critic of Scientology, were physically present

never left alone. She said Dain was even accompanied to the bathroom, and a woman slept on each side of her in bed at night.

A male guard was said to have slept on a mattress on the floor that blocked the doorway.

During her captivity, Dain was not persuaded to forsake Scientology and she is now living with a group of Scientologists. A Scientology spokesman said she did not wish to talk to The Times about her ordeal.

Patrick twice has been convicted of the unlawful imprisonment of religious sect members and has served a total of 10 months in jail.

OUR 7TH CHILD, MICHAEL CHRISTOPHER, WAS BORN on the day of love, Valentine's Day, February 14th at 4:55 a.m. He weighed almost 4 kilos. This birth has been such a beautiful experience in every way & a definite answer to prayer.

WE HAD WANTED TO BE ABLE TO HAVE THE BABY AT HOME. One hospital where the children sang 3 times said that we could have the baby there for free, but to me it was a closed door as they wouldn't allow Secundus to be with me, & he's always been such a support & partner in the job of delivering our babies.

WE REALLY PRAYED & INQUIRED IF THERE WAS A MID-WIFE living in our area. In the "practicante" office where we went there was a midwife who agreed to deliver the baby "for nothing". All we had to do was get a plastic pan, disinfect & iron sheets, get a focal light & raise the bed to a higher level & she supplied the rest.

GOD'S TIMING IS SO PERFECT, & sometimes He's just waiting on us to do our part.
