were no journalists & nothing has come out in the press. The judges also paid attention a lot more, & allowed us to speak without cutting us off in the middle of our testimony (as in the last trial). But what seemed to impress everyone the most was this new lawyer, as an anointing really fell on him. People remarked at the fluency in which he spoke. And it seemed like he even surprised himself at how he went to the attack in defending us.

K. HAD ALWAYS TALKED TO US ABOUT THE MENTALITY OF THE GREEK COURTS, how important it is to have a man of influence to influence the judges. But what seems to have actually happened is that this new lawyer, after seeing Angelo's & myself and P.'s witness, and seeing K.'s dedication to us & how much conviction K. has about the righteousness of our cause, it seemed like he got overtaken by the Spirit! It reminded me of when Saul prophesied one time when he was going out against David, when the people said, "Is Saul also now a prophet?" It was like people were say-

ing, "Is N. now with them?" as he got so into it. (K. had spent a whole day out visiting with us this past week, & is very turned on, he sang "Into My Heart" with us & his kids!)

N. AND K. BOTH WERE SHOCKED AT THE OUTCOME OF THE SUPREME COURI, as the outcome of this case could affect future legislation & probably religious freedom here too. So the judges asked for a one week delay on giving the decision as they wanted to study all the laws N. and K. had brought to their attention, & the outright contradictions in these papers coming from Italy.

ME KNOW THAT BY NO MEANS IS THIS.
BATTLE OVER YET, but at least it seems there is a little more chance of winning. And we still have the Minister of Justice as a last resort, if needs be. Also we cannot forget, "If God be for us, who can be against us?" Though we know we shall be "hated of all nations" in the Last Days, we also know that "His hand is not shortened that it cannot deliver." PTL!
